### Subject: Transition of Business Operations and to Open New PD Accounts

Further to the announcement by Bangalore International Airport Limited vide Circular no. BIAL/S&D/ 22-23/-AB57 dt. 14<sup>th</sup> January 2023 (attached herewith) that Menzies Aviation (Bengaluru) Private Limited (MABPL) has been appointed to operate Air Cargo Handling for Terminal-1 which is currently operated by Menzies Aviation Bobba (Bangalore) Private Limited, we would like to request your attention for the following.

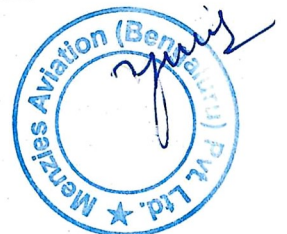
This transition will happen on 24<sup>th</sup> of May 2023 at 00:01 hours. MABPL shall have the right to operate Cargo Terminal-1 and provide Cargo Handling Services for a period of 15 (fifteen) years from the Date of handover of the existing Cargo Terminal. As part of this process and to allow us to provide continuity of service we request our customers/agents/CHAs/Shippers and Consignees to open new Pre-deposit accounts with us well before the date of transition to avoid any inconvenience in carrying out transactions.

- 5) Self-certified copies of GST and PAN.
- 6) Copy of CHA Licence issued by the Commissioner of Customs.
- 7) Minimum deposit amount of Rs. 5000/- to be transferred to the below bank account by 15<sup>th</sup> May 2023.
